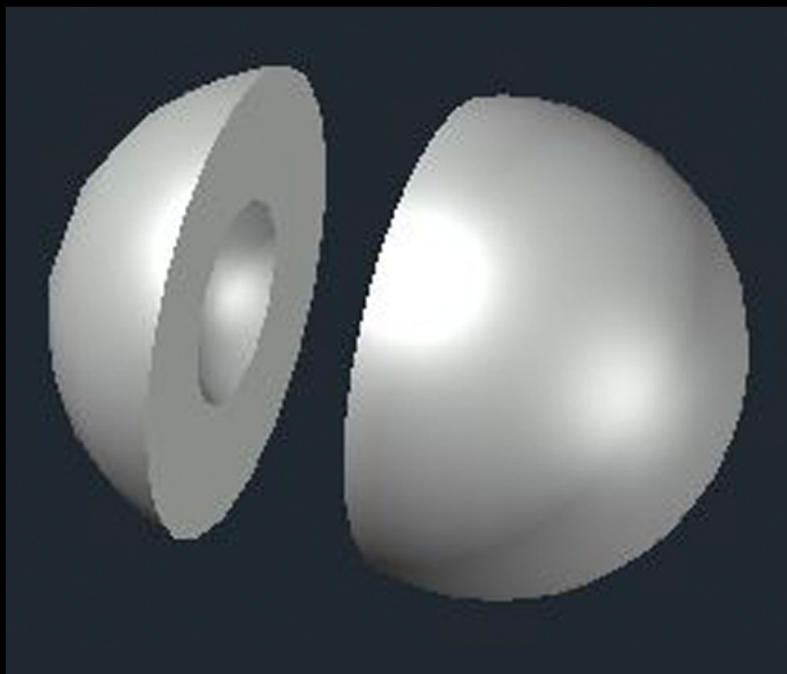

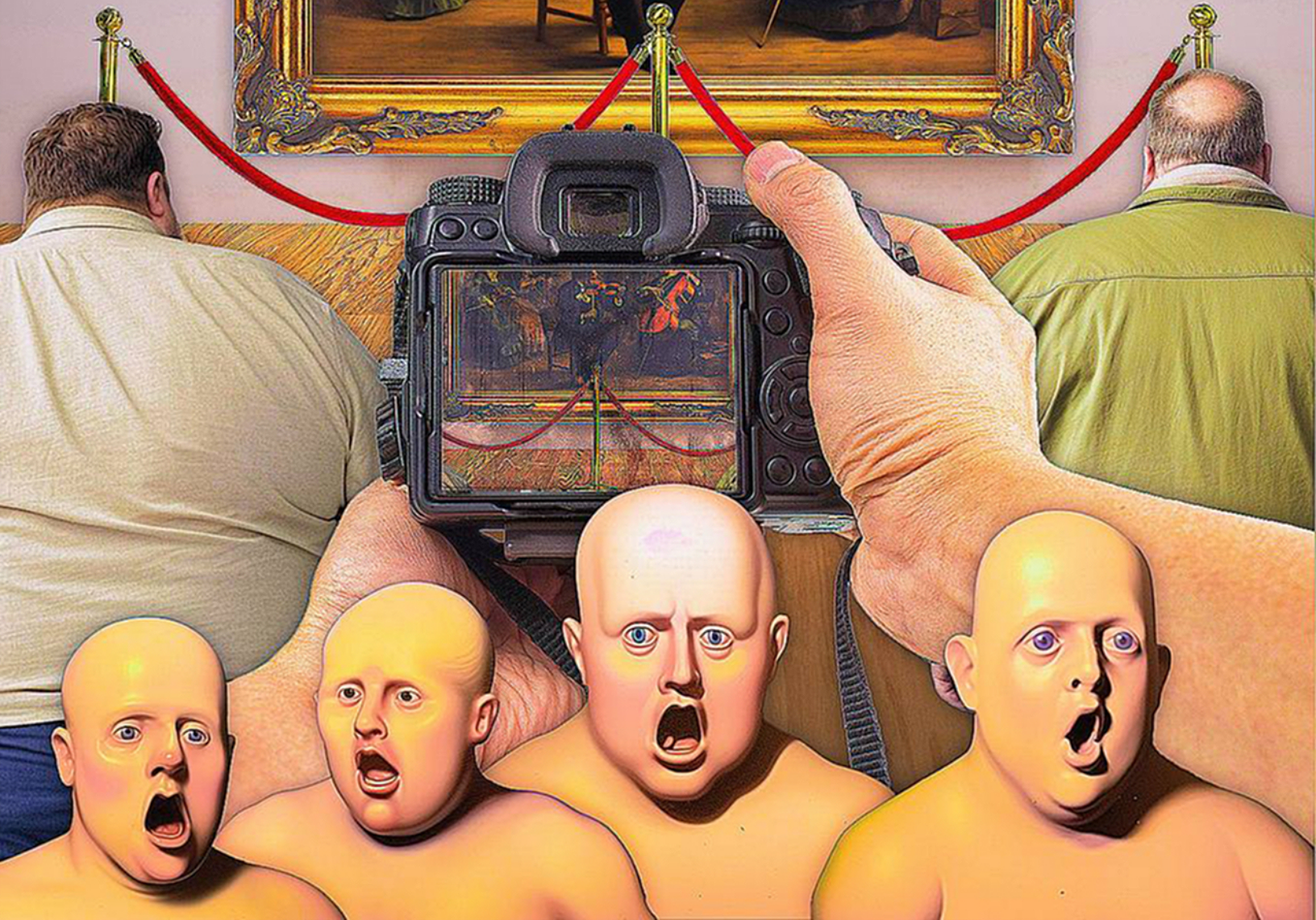
Here are the purported dimensions of Orb 4:

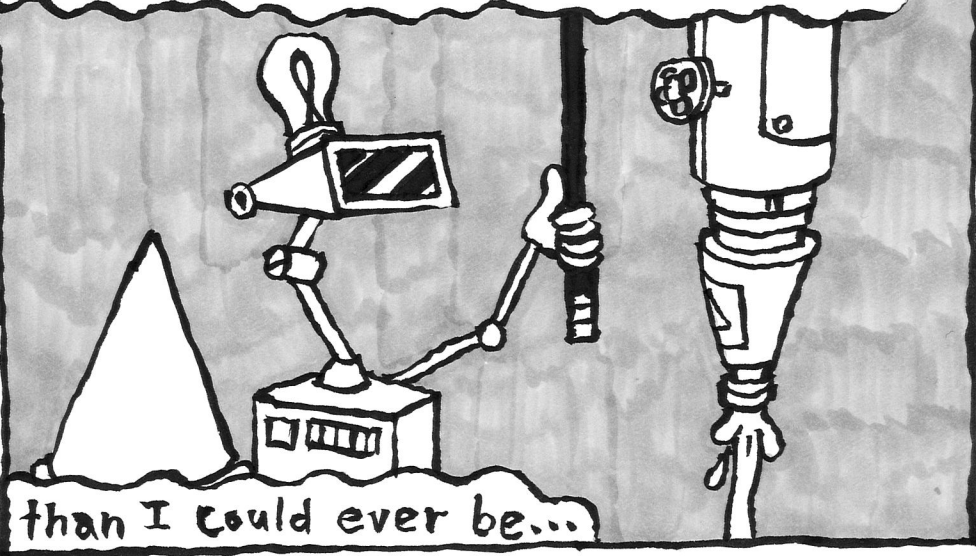

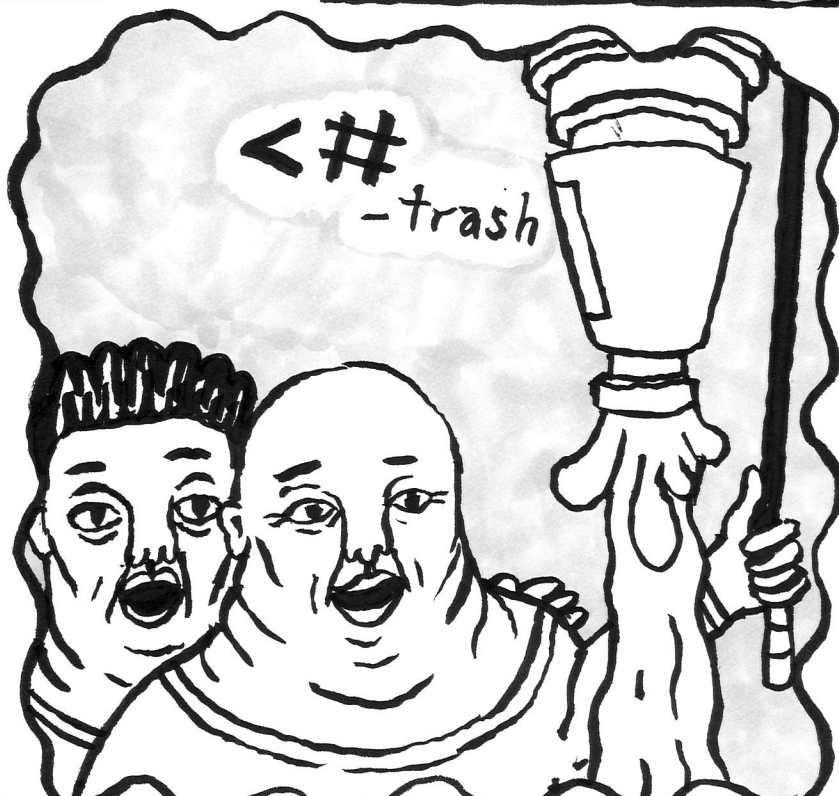

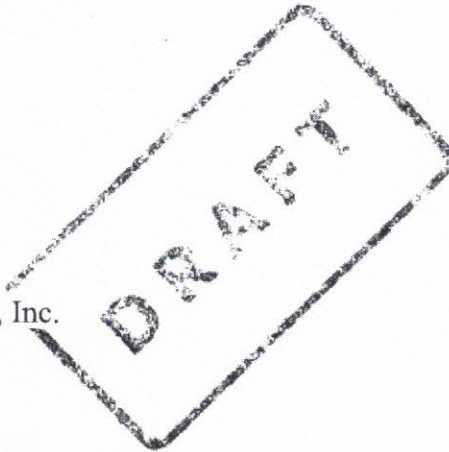

**Re: Cancellation of August 2019 Option Agreement
and sale of the Skeleton Landlord intellectual property**

Dear shitlords:

I write to notify you that my clients, MeMoreTV LLC Global d/b/a MeMoreTV Triple Play Classic, Skeleton Realm LLC, Douglas "Doug" Bleichner (hereafter referred to as Bleichner), Samuel "Sam" Wagstaff (hereafter referred to as Wagstaff), **hereby exercise their right to cancel** the August 10, 2019 Development and Exclusive License and Option Agreement ("Option Agreement") concerning the sale of the television pilot, "Skeleton Landlord."

In case you didn't know, Georgia courts have long held that "[a]ll contracts executed on Georgia soil shall be read to include an implied right of 'take-back'... provided the contract does not contain an express 'no take-backsies' clause." *See Sorm v. Borm*, 124 Ga. 180, 184-5 (1912). The implied right of take-back is "absolute" and, "...when invoked, immediately cancels the

contract... **notwithstanding any arbitration or choice of law provisions.**" *See Mubb v. Porsonville Restaurant Association, LTD* (citation omitted); *citing Burlow Chemical, Inc. v. Dow, Inc.*, 120 F.3d 2, 6-7 (8th Cir. 1973) (emphasis in original).

The August 2019 Option Agreement was executed on Georgia soil and did not contain a "no take-backsies" clause (rookie mistake!). The Agreement therefore contains an implied take-back provision, which **my clients immediately invoke**. Accordingly, your clients' (and their assignees') rights, title, and interest in Skeleton Landlord (including but not limited to copyright, trademark, distribution, merchandising, or any other rights) **are hereby extinguished and immediately revert to the original owners, i.e., Bleichner and Wagstaff.**

Your clients are instructed to return all scripts, scrolls, napkin notes, stone etchings, digital media, audiovisual recordings, promotional materials, source code, keychains, and any other materials pertaining to Skeleton Landlord. All such materials should be hand-delivered to my Porsonville office by the close of business today, May 26, 2023. Additionally, any broadcast of Skeleton Landlord by your clients (including on third party streaming services) is in violation of federal copyright law and must be taken down forthwith.

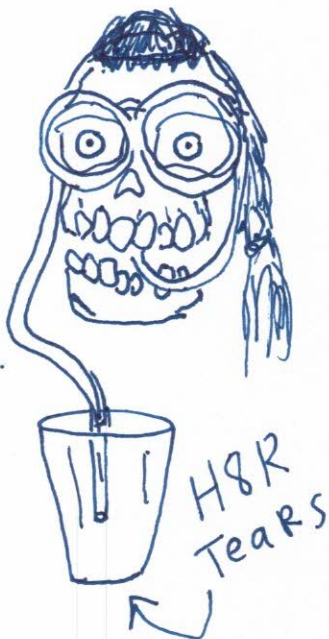
Lastly, if your clients fail to comply with the above instructions, my clients will vigorously pursue all legal and equitable remedies, including punitive damages, injunctive relief, and, of course, reasonable attorney's fees under the DMCA (mine are quite substantial!).
