Defendants Samuel Wagstaff and Douglas Bleichner were fined \$175,000 and given 18-months probation for violating Georgia Code Title 16, Chapter 12, Article 2, Part 1, Section 16-12-34 by accepting a bribe to influence the outcome of a sports event. The State of Georgia filed charges against the defendants, and the case was heard in the Superior Court of Fulton County.

Mr. Wagstaff, you are not to whisper with your client while he is on the stand.



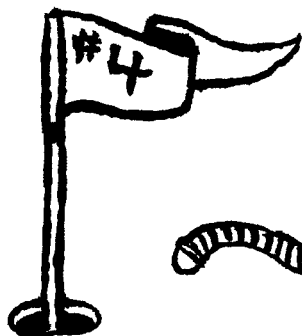

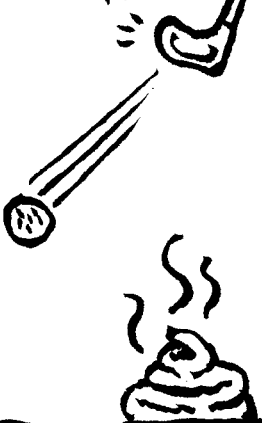

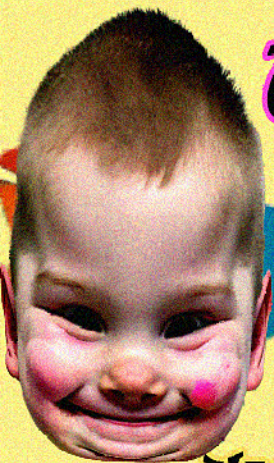
